bfbi FEED ASSURANCE SCHEME



Historically, most of the quality and safety problems that have arisen in animal feed have all been associated with the feed ingredients rather than the feed manufacture. It is essential, therefore, to ensure that an effective assurance programme covers feed ingredients.

As a consequence, FEMAS was developed by AIC and industry to provide assurance that the feed materials that are procured for processing into animal feed are safe, legal and of an agreed quality standard.

However, the requirements of FEMAS do not take into account the economic and practical issues encountered by brewers classified within the EU as "smaller brewers" (less than 200,000hl/year output).

BFBi as sector lead for moist co-product feed, providing expert guidance to industry and government via the BFBi Moist Co Product Feeds Committee, created a bespoke assurance scheme aimed at "smaller brewers".

WHY SHOULD YOU JOIN?

Any brewer/distiller giving or selling brewers' grains or draff; ullage; spent yeast to farm via a UFAS trader MUST be either FEMAS or BFBi Feed Assurance accredited. No trader is able to pick up grains/yeast etc from a non accredited source.

Any brewer/distiller giving or selling brewers' grains/draff; ullage; spent yeast direct to farm is strongly recommended to be either FEMAS or BFBi Assurance accredited, in order to show due diligence and traceability within the supply chain.

Farmers selling milk or meat to retail who are, in themselves, accredited via AFS/Red Tractor and/or other accreditation schemes will need to show traceability within their supply chain – the BFBi Feed Assurance Scheme provides this via auditing and validation of:

- Good Manufacturing Practice (GMP)
- Risk Assessment/HACCP
- Identification and traceability of feed materials for recall
- purposes Legislation
- Quality Assurance

Accredited farmers will be asked to provide evidence of traceability – the BFBi Feed Assurance Scheme certificate provides this.

WHY SHOULD YOU NOT JOIN?

Any brewer/distiller giving or selling brewers' grains/draff, ullage and/or spent yeast to animals not intended for the food chain or supplied to farmers not accredited within one of the retail/ Government schemes does not need to be accredited.

However, the fundamental principles of GMP (risk assessment, HACCP, QA) still apply and you may wish to join in order to have these audited and validated on an annual basis in order to show evidence of best practice.

LEGISLATION

Food and drink businesses (including retailers) that supply food products for use as animal feed must comply with the requirements of the Feed Hygiene Regulation (183/2005). This applies whether or not food products are supplied via a food processor or sent direct to farms. Businesses providing food products for pet food are also covered by these requirements.

In addition, a number of codes of practice and quality assurance schemes apply to the production and delivery of feed to farms and the sourcin*g*, storage and handling of feed mate*r*ials and compound feeds.

The main codes of practice are *those drawn* up by the Agricultural Industries Confederation (AIC) and the Grain and Feed Trade Association (GAFTA). These, and other codes (including the BFBi Feed Assurance Scheme) - developed by the feed industry, farmers, unions, and trade bodies, are voluntary, but help ensure that measures are in place to address identifiable hazards and trace feed materials.

The ultimate aim of both legislation and self-regulation is to ensure that animal feed is safe, wholesome and does not present any danger to animal or human health and the environment. Relevant feed legislation, appropriate to the UK includes:

- The Feed (Hygiene and Enforcement) (England) Regulations 2005 (S.I. 2005 No. 3280)
- Regulation 183/2005 on feed hygiene (applies at all points in the production, supply and use of feed)
- Feed Labelling Legislation (Commission Directive 98/67/EC)

It is a key objective of the scheme that companies certified are compliant with the above and that European legislation remains as non incumbent as possible.
